I can’t wait to roll-up my sleeves and get to work making sure our public charter schools’ voices are heard in the halls of the State House and all around New Jersey.”

Danielle West-Augustin serves as the Chief Academic Officer and Director of Queen City Academy Charter School, high-performing public charter school in Plainfield. Charter schools are tuition-free public schools run by non-profit organizations open to all students regardless of zip code, race/ethnicity or ability level. Charter schools operate with more flexibility than traditional public schools in exchange for increased accountability and high financial, academic and managerial standards by an authorizer. A “charter” is a contract with an authorizer detailing the school’s mission, program, performance goals and methods of assessments. In New Jersey, the New Jersey Department of Education serves as the sole authorizer and oversees all public charter schools in the state.
